4. Terms of delivery:

-The goods are to be accompanied with delivery note. The delivery note is to contain the country of origin.

-The goods originating outside the European Union are to be sent with the documents needed for customs clearance. (Invoice, certificate of origin, EUR1, EUR2)

-The fulfilment of the order is to be made according to the delivery plan.

-In case this order is not confirmed within 8 days, it is regarded as accepted with its content.

-In case of delay in delivery caused by the supplier, the RÁBA-JÁRMŰ Kft. is entitled to demand a penalty from the supplier. Its value is 0.5%, for every full week of delay.

-If the expectable delay of the supplier jeopardizes the fulfilment of the contract obligations of RÁBA-JÁRMŰ Kft, RÁBA-JÁRMŰ Kft is entitled to recede from the contract, and purchase the goods from another supplier.

- Furthermore, RÁBA-JÁRMŰ Kft reserves the right to claim a compensation for its consequent losses.

- RÁBA-JÁRMŰ Kft. reserves the right to modify this PO without any costs of compensation.

-The ordered goods are to fulfil the relevant requirements of the group of products.

- Regarding the standard goods, the relevant standards are valid..

- Regarding the non-standard goods, the regulations of RÁBA-JÁRMŰ Kft are prevailing.

- In case of items with drawing numbers, it is requested, to fulfil all the requirements indicated on the drawings and to accompany a Quality certificate to every lot, according to the quality assurance requirements.

-If there is not any relating separate agreement or any written notification, the standards, valid in the year of placing the order are prevailing.

-The start of a serial production is only allowed, when having an accepted first sample report, in case the goods are subject to PPAP.

- In case of supplying components belonging to the Ministry of Defence, the supplier - on the basis of previous agreement - is bound to allow the control of their system by the QS experts of the MoD, furthermore,

all requirements of this contract may be subject to GQA. You will be notified of any GQA activity to be performed.



- On all the documents, besides the Supplier number, the PO number, the drawing number with the valid version number and the denomination, the RÁBA item numbers are also to be indicated for the sake the easier identification and traceability..
- In the order confirmation, the prices and customs tariff numbers are to be indicated.
- The supplier accepts that the checking of goods purchased confines to the checking of delivery notes, the other shipping documents, the number of goods delivered as well as the external damages of the packaging at RÁBA-JÁRMŰ Kft, that is, the Supplier's products are, by regular operation, checked at the beginning of the production process or as parts of finished goods.
- The Supplier accepts that, in case of an attributable faulty performance or if the fault cannot be repaired without any loss in value within a short time, at RÁBA-JÁRMŰ Kft is entitled to ask for replacement of the goods.
- In case parts or finished goods get damaged - attributable to a faulty performance or originating in the Supplier's products - during the production process or the operation by the End-user, at RÁBA-JÁRMŰ Kft is entitled to demand the full recovery of all its losses.
- Regarding the cases not regulated by the contractual conditions, the regulations of Civil Code are valid.
- On shipping the goods, one copy of invoice is to be faxed to No. +36 96 624 084 and the first copy of invoice (original) is to be mailed to the given postal address.
- In case of a delayed payment, maximum a default interest on overdue payments according to Civil Code is to be charged.
